# IMPORTANT DATES

- UNT:
- Registration and implementation until June 30.
- Registration for a special exam (only "General Medicine", "Dentistry", "Nursing") – from June 20 to August 20.
- Special exam for grant applicants – from June 20 to July 22.
- Special exam for the paid department – from July 22 to August 20.
- Submission of an application for participation in the competition for the award of a grant through egov.kz from 13 to 20 July.
- Enrollment in the Medical University from August 25.





*To participate in the competition for the award of an educational grant of higher education and (or) enrollment in paid training, persons who have passed the UNT and scored according to its results are allowed:*

- *in the field of education "Health"– at least 70 points\*.*
- *programs "Biomedicine" and "Technology of pharmaceutical production"– at least 50 points\*.*
  
- *At least 5 points in each subject.*

*When passing the UNT in electronic format in the competition for the award of an educational grant of higher education at the expense of the republican budget or the local budget, the applicant participates with one of the two UNT results that have the required number of points.*

**Citizens of the Republic of Kazakhstan who enter on the basis of a state grant enter into a contract for working out at least 3 (three) years in accordance with the procedure established by the Decree of the Government of the Republic of Kazakhstan dated March 30, 2012 No. 390 "On Approval of the Rules for Sending a Specialist to Work, Granting the Right to Self-employment, Exemption from the obligation or termination of the obligation to work out by citizens who studied on the basis of a state educational order, and amendments and additions to the Resolution of the Government of the Republic of Kazakhstan dated January 23, 2008 No. 58 " On Approval of the Rules for Awarding an Educational Grant"**



## The applicant submits the following documents:

- 1) application;
- 2) document on general secondary, technical and professional, post-secondary or higher education (original);
- 3) identity document;
- 4) 6 photo cards measuring 3 x 4 centimeters;
- 5) medical certificate in the form 075/y;
- 6) UNT certificate;
- 7) an extract from the statement (for those entering the educational programs of higher education "General Medicine", "Dentistry", "Nursing");
- 8) electronic certificate of the award of an educational grant;
- 9) a paper folder, white;
- 10) two envelopes; two files (dense).

Service recipients – citizens from among the disabled of groups I, II, disabled from childhood, disabled children, persons equated by benefits and guarantees to participants and disabled people of the Great Patriotic War, persons of Kazakh nationality who are not citizens of the Republic of Kazakhstan, orphans and children left without parental care, as well as citizens of the Republic of Kazakhstan from among young people who have lost or remained without parental care until adulthood additionally submit documents confirming the granting of preferential rights and quotas.

***Together with copies of the documents, their originals are provided for verification, carried out in the presence of the applicant. After verification, the original documents are returned. If you provide an incomplete list of documents specified in this paragraph, the admission committee does not accept documents from applicants.***
